GOVERNING BOARD POLICY

POLICY CODE: GBI

District A. The district and persons acting on behalf of the district or a person Participation who aids another person acting on behalf of the District must shall not in Political use TUSD time, personnel, its employees, equipment, materials and Activities supplies, buildings, or other resources including email, for the purpose of influencing to influence the outcome of an election, except that: B. The district may distribute informational reports on a proposed budget override election and hold or participate in public hearings as provided in A.R.S. §15-481 and -The district may distribute informational pamphlets on a proposed <u>B.</u> bond election as provided in A.R.S. §15-491 if those informational pamphlets present factual information in a neutral manner (except for those arguments allowed under A.R.S. 15-481). -The prohibition on the use of public resources to influence the outcome of bond, budget override and other tax-related elections includes the use of School District-focused promotional expenditures that occur after an election is called and through election day. This prohibition does not include routine District communications which are messages or advertisements that are germaine to the functions of the District and that maintain frequency, scope and distribution consistent with past practices or are necessary for public safety.

C. Nothing in this policy shall preclude the District from producing and distributing impartial information on elections other than District budget override elections or The district may reporting on official actions of the Governing Board.

- D. As required by state law, the district will not spend monies for membership in an association that attempts to influence the outcome of an election.
- E. The District shall not make expenditures for literature associated with a campaign conducted by or for a District official.

Definitions	As used in this policy, "election" means an election conducted by federal, state, or local government. This policy does not apply to an election conducted by student government or a private organization.	
Regulations	The Superintendent is authorized to has adopted administrative regulations GBI-R and regulations administrative guidelines to implement this policy and its related Administrative Guidelines: Restrictions on Political Activities in accordance with state law.
