Should Mr. Starks request a hearing, I move to designate a hearing officer to hold the hearing, hear the evidence, issue subpoenas, prepare a record, and issue a recommendation to the Governing Board for action.*

Roger Pfeuffer stated that in lieu of a statement of charges, he was recommending that the Board accept the resignation of Debra Lynn Riess as a teacher with TUSD, effective at the end of the 2005-2006 contract year.


Bruce Burke moved approval; Joel Ireland seconded. Approved 3-1. Judy Burns voted no. Alex Rodriguez was not present for the vote.

Judy Burns commented. Rob Ross provided legal advice that since it is a related matter, the Board may take action on the resignation.
