Board President Adelita Grijalva directed Utterback Middle Magnet School parents to Michael Konrad and Utterback Middle School Principal; and, asked if Board members wanted to respond to Call to the Audience.

Cam Juárez asked for a complete report of the issues at Utterback Middle Magnet School and plan on how they were going to be addressed. Mark Stegeman thanked Utterback Middle Magnet School parents for coming forward. Michael Hicks wants a report on who was discouraging Utterback Middle Magnet School parents from coming forward. Kristel Foster indicated she and Dr. Sánchez are aware of what is happening at Utterback Middle Magnet School and asked for more information on what is being done to help with the situation.


