ACTION ITEMS

10. Pima County School Superintendent's Community Advisory Committee for the Tucson Unified School District Governing Board Vacancy – Selection of a Fifth Committee Member and Alternate

Adelita Grijalva outlined possible options for reaching agreement on a fifth Committee member and an alternate. Due to the cost to the district and thus to the students, she does not believe an election is appropriate.

No action required.

Adelita Grijalva moved to determine a fifth member by a random drawing from names previously submitted by board members. Motion failed for lack of a second.

10. Pima County School Superintendent's Community Advisory Committee for the Tucson Unified School District Governing Board Vacancy – Selection of a Fifth Committee Member and Alternate (cont.)

Mark Stegeman referred to his previous suggestion (from the November 15 meeting) to select two of the submitted names and proceed with a random drawing between the two to select the fifth member and one alternate. However, since receiving negative comments about this approach, he did not proceed to support it.

Miguel Cuevas agreed that the election option is not in the best interest of TUSD students and offered a motion to appoint Juan Ciscomani as the fifth committee member.

Martha Durkin provided legal advice at the request of board members.

Following further discussion, Adelita Grijalva moved to allow each board member to submit a different candidate name in an effort to reach agreement. This motion failed for lack of second.

Miguel Cuevas moved to appoint Juan Ciscomani as the fifth member; Mark Stegeman seconded. Approved unanimously.

Following the appointment of Mr. Ciscomani, Miguel Cuevas moved to appoint Colleen Niccum as the alternate; Michael Hicks seconded. Approved unanimously.
