PURPOSE:

Approval to award Invitation for Bids (IFB) 16-60-C20, Musical Instruments, Parts, Accessories and Service.

DESCRIPTION AND JUSTIFICATION:

This is a multi-term contract with awards recommended to multiple vendors beginning upon award with annual renewal options through December 31, 2020. Determination has been made to award IFB 16-60-C20 to multiple vendors to meet the extensive and varied needs of the District. Based on the demographics of the District, the variety of musical instruments, parts, accessories and service needed for all District schools, it has been determined to be in the District's best interest to award this contract in this manner. As the second largest school district in Arizona, it is determined that awarding to multiple vendors would provide the needed quantity, diversity of products, quality, service and/or delivery needed to the district. Award recommendation is based on abstract results per AZ Administrative Code R7-2-1031, Bid Evaluation and Award. An Executive Summary with the details of the recommended vendors is provided for review.

The notice of Invitation for Bids was sent to 158 vendors using the department's official competitive sealed solicitation website AZ Purchasing. Twelve (12) vendors responded with bids and there were twenty-seven (27) No-Bids.

Estimated Annual Expenditures are \$110,000 a year (X 5 = \$550,000 over the life of the contract). Expenditures come from various school and department budgets.

Sean Randel, Fine Arts Department, will be present to answer questions regarding the use of the contract. Kevin Startt, Director of Purchasing, will be present to answer questions regarding the procurement process.
