Permission to award a construction contract to Sunland Asphalt, in the amount of \$281,360.00 which includes the Base Bid and a 10% contingency for Cholla High School - All Weather Running Track.

DESCRIPTION AND JUSTIFICATION:

Bonds and Architecture Staff have worked with the School Administration along with the Interscholastics Department to develop the scope of the project. This project will address the replacement of the athletic track with new materials to reconstruct the existing running track for increased safety to students and staff and will increase life usage of the track. The existing track is at the end of it's useful life. Sunland Asphalt, a contractor from The Cooperative Purchasing Network (TCPN), was selected based on their knowledge of installation and past performance.

The Project Manager is Linda Wright.
