Governing Board meeting agendas are available for public review at the time the governing board meeting notice is posted to the public body and the general public. Both the agenda and the meeting notice will be posted at least 24 hours prior to the meeting except in case of an actual emergency or a recessed and resumed meeting as described in A.R.S. 38-431.02(D) (E). The notices will be posted in English and in Spanish on the TUSD website and in the posting cabinet at the front door of the TUSD administrative office, Morrow Education Center, 1010 East Tenth Street.

### Board Agenda Information Process

- A Governing Board packet will be available for public review by 10 a.m. the day prior to the board meeting and will continue to be available during regular business hours until the start of the meeting. Agendas and packets are subject to change up to 24 hours prior to the Governing Board meeting.
- In accordance with a public records request, copies of materials may be obtained pursuant to Board Policy ~~#1150~~/KDB – Public Information/ Public’s Right to Know – Freedom of Information.
- Questions regarding board meeting agendas or materials may be directed to the Director of Staff Services, who will forward them to the Board President and Superintendent, or copy them on any replies, as appropriate.

### Order of Business

Unless the Board votes otherwise at a previous meeting, the order of business at each meeting shall be as listed below. A section may be omitted at a specific meeting because it has no agenda items in that category. The Audience Call is omitted from meetings at which the agenda includes no items for Action or Study/Action, unless the Board or the President of the Board have placed an Audience Call on the posted agenda for that meeting. Within each section, agreed to by a majority of Board members present at each meeting, the order of business shall be as listed on the posted agenda, but the Board may vote during the meeting to reorder items within a section. The following sections may not appear on all agendas.
