PURPOSE:

To present for study the proposed Tucson Unified School District's 2013-2014 Performance Based Compensation Plan under A. R. S. 15-922 (Proposition 301)

DESCRIPTION AND JUSTIFICATION:

Since August 27, 2012, the TEA/TUSD Joint Committee on the Classroom Site Fund (Proposition 301) has been meeting to update the current plan for approval by stakeholders and the Governing Board, in accordance with statute. Given the fact that new statute will require the pay for performance portion of the 301 plan be tied to teacher evaluations beginning in SY 2014-2015, the Joint Committee thought it best to roll over this year's plan to next year with only minor revisions. Revisions include only date changes and clarity in expectations based on questions and comments received this year. In this way, teachers will not have to learn a new plan for three years in a row (2012-2013, 2013-2014 and 2014-2015). As was the case in last year's plan, this year's plan is focused on improving student achievement by fostering professional collaboration which will result in providing specific interventions for students in academic need. The Joint Committee believes this work will result in improved achievement for individual students, school, and for our District as a whole.

The success of this year's plan cannot be evaluated until this June, when test results are made public.

This item will allow Board members the opportunity to provide the Joint Committee with specific feedback regarding the plan before we move to ratify with stakeholders.
