PURPOSE:

Proposed revision to Policy GBP was discussed at the 11/13/18 Governing Board meeting; Governing Board member Dr. Mark Stegeman's proposed changes were designed to prohibit Tucson Unified School District from keeping any formal or informal list of individuals designated not eligible for hire or re-hire with the goal of pre-empting any possible reemergence of previous practice. Board discussion raised the following concerns, which were to be addressed by staff in alternative language for further discussion on 12/11/18 (the item was not reached): concerns about re-hiring those employees terminated for harming (or threatening harm) to students or other members of the school community. At the 1/15/19 meeting, alternative language to revise Policy GBP, GBJ and GCAA was presented to the Board for discussion. Attached to this item are draft revisions to the listed policies incorporating the language presented at the 1/15/19 meeting. The Governing Board will discuss and thereafter may refer for consideration and comment through the Board Policy Development Process (BG-E1).

Prohibition against designating a former employee as ineligible for rehire
 Specifically authorizing use of evaluation, disciplinary and termination information contained in district records to be used to screen applicants

-Retention of personnel records -Employment references limited to neutral information unless a release is provided by the employee or release is allowed or required by statute or if a mandatory report to the State Board or law enforcement was required
