TITLE:	Approval and Commitment of Funding for New Local Area Network Equipment and Installation for School Year 2013-2014

## PURPOSE:

To approve funding for new Local Area Network (LAN) equipment and installation during the 2013-2014 school year pursuant to the existing contracts with ACE and WWT.

## DESCRIPTION AND JUSTIFICATION:

As part of the IT Infrastructure Modernization Initiative, Local Area Network equipment required for building LAN's and wireless connectivity is currently being installed under multi-year contracts with World Wide Technologies (WWT) and Arizona Communications Experts (ACE). This E-Rate request covers the second and final year of the implementation.

LAN equipment and installation is E-Rate eligible as a Priority 2 request and is typically funded for schools and other instructional facilities that have a sufficiently high E-Rate discount rate (discount rate is determined by participation in the National School Lunch Program). The Schools and Libraries Division (SLD) starts funding Priority 2 requests for sites with 90% discount rates and continues funding at lower discount rates until the funds run out. Historically, SLD has cut off funding at or near the 80% discount rate with some exceptions.

Primarily in view of SLD's past Priority 2 funding practices, we decided to implement the LAN upgrades (as well as telephony upgrades) at admin sites (not E-Rate eligible) and schools with lower than 80% discount rates during school year 2012-13. That work is under way. This year's E-Rate request covers implementation of LAN upgrades at all remaining school sites – that is, schools with 90% or 80% discount rates.

In order to receive E-Rate discounts for the 2013-2014 school year, TUSD must submit E-Rate applications for the equipment and installations by March 14, 2013 and certify that the District has committed the funding required to pay the non-discount portion of either 10% or 20%.

Should the Board choose to approve this item, it would consist of the following for the 2013-2014 school year:

- A recommendation for new LAN equipment and installation for a total cost of approximately \$15,801,125.
- A recommendation to commit the funding required to pay TUSD's applicant share of the total cost, which will be approximately \$2,184,336.

The District will be required to pay the full cost for LAN equipment and installation until the E-rate applications are approved. Upon approval, TUSD will receive a reimbursement for E-rate's share of the cost.

Please note: Due to increasing demand for E-Rate funds, funding for sites with discount rates of 80% has not been available for the past two years. In the event that funding at discount rates of 80% is again not available in 2013-2014, TUSD will be responsible for the total cost represented in this request at the 19 schools affected, which will be \$6,042,238 . Should this occur, staff will bring the requirement to the Governing Board for approval consideration.

This supports the Superintendent's Goals of achievement, student enrollment and customer service.
