### PURPOSE:

To consider an Intergovernmental Agreement with the City of Tucson outlining the joint responsibilities necessary to improve and utilize recreational facilities at Doolen Middle School.

### DESCRIPTION AND JUSTIFICATION:

In association with the Fort Lowell Soccer Club Inc, the City would like to enter into a partnership with TUSD to improve and maintain fields at Doolen Middle School. The project would involve the installation of soccer fields and lights with all associated controls. The attached agreement replicates the agreement at Townsend to provide two sites for the soccer club to play.

Per this agreement TUSD will design and build the fields and other improvements including a walk path and field lighting. The Fort Lowell Soccer Club Inc. will fund the lighting and will be able to use the fields, through the City reservation system, when they are not being used by TUSD. The City will schedule all uses outside the times the fields are being used by TUSD. The City will maintain all areas within the perimeter of the walkway (essentially the walkway and soccer fields) and the field lighting, and they will pay for the electricity associated with the lights. TUSD will maintain all other areas and provide water for the fields.

HOW THIS RELATES TO SUPERINTENDENT'S GOAL(S): This agreement has the potential to support the Achievement Goal by providing a maintenance savings of approximately \$10,000 annually. It supports the Customer Service Goal by providing a better set of fields for the soccer community and an improved recreation area for adjacent neighborhoods.
