PURPOSE:  To request that the Tucson Unified School District's Governing Board approve the expenditure required to purchase the 2014-2015 Advanced Placement testing materials from College Board, in addition to obtaining Governing Board approval for Sole Source Purchase Designation for the College Board.		
DESCRIPTION AND JUSTIFICATION:		
The cost to the College Board is for providing exams for the 2014-2015 Advanced Placement Testing. The majority of the expenses will be provided through student fees. Sole Source Determinations over \$250,000 require Governing Board approval in accordance with GB Policy DJ - Purchasing Procedures.		
The existing multi-term Sole Source Determination - 13-49-17 - for College Board is for PSAT and NMSQT Testing and is less than \$100,000. Adding the expenditure for Advanced Placement testing will bring the Sole Source Designation to over \$250,000.		
Efforts to adequately determine the sole source designation have been documented in accordance with Arizona Administrative Code R7-2-1053. Estimated spend on this sole source vendor for fiscal 2015 is at \$295.000.		
Chuck McCollum, Director of Career and Technical Education, and Kevin Startt, Director of Purchasing, will be present to answer questions regarding the use of College Board testing materials.
