PURPOSE:

To approve an Intergovernmental Agreement between the University of Arizona and Tucson Unified School District for the administration of the May 2014 Advanced Placement (AP) exams on the U of A campus.

DESCRIPTION AND JUSTIFICATION:

Because of the specific criteria needing to be met for the administration of these exams it is more efficient and less disruptive to the sites if we hold them off campus and at one location. The University of Arizona Testing Center and the campus itself provide TUSD with the expertise, experience and space to handle this type of testing.

The University of Arizona will provide rooms, proctors, necessary equipment, and test security. This allows TUSD campuses to run without having to worry about interfering with the educational process for those two weeks, in which an estimated 2700 students will take the AP tests.
