TITLE:	Establishment of Fee to be Funded Out of Tax Credit Monies for Extracurricular Foreign Student Travel Related to Safford K-8 School's Student Trip to Korea in May/June, 2013

PURPOSE: To request Governing Board approval to establish a fee for foreign student travel for Safford K-8 School students traveling to Korea, payable from Safford's Undesignated Tax Credit Fund.			
DESCRIPTION AND JUSTIFICATION: This is the third year that Shinan Gun and Safford K-8 School have participated in the Tucson Korean Ambassador Program. Due to the success of the program, the Educational Department of Shinan Gun has invited four students from Safford K-8 School to study and travel in Shinan Gun in late May and early June (exact dates still to be determined).			
Shinan Gun will pay for two students and Safford will pay for two students. The funding will come from Safford's Undesignated Tax Credit Fund, which has been approved by Safford's Site Council, in the approximate amount of \$4,000.00. The Shinan Gun government will pay the other approximate amount of \$4,000.00.			
Theresa Tenace, Safford Principal will attend the Board meeting to answer questions.			
SUPERINTENDENT'S GOALS: Achievement Students participating in the Tucson Korean Exchange Program are exposed to other cultures, giving them a global perspective on the competition when working in a global society, and experiencing the rigor and expectations in other educational settings in those societies.
