PURPOSE:

Permission to award a construction contract to Concord General Contracting, one of TUSD's Job Order Contractors (JOC) in the amount of \$438,000 which included the Base Bid and a contingency amount for the receiving school, Hollinger K-8 School for the conversion to the new grade configuration. The scope of this project was submitted to and approved by the Desegregation Court.

Marcus E. Jones, R.A., Program Manager of Bonds and Architecture, will be available to answer questions.

DESCRIPTION AND JUSTIFICATION:

Hollinger Elementary School was selected by the Governing Board to serve as the major receiving school for closure of Wakefield Middle School and to be converted to a new K-8 school. The scope of the project will include creation of project labs, PE changing rooms, PE field improvements, interior painted, general classroom revisions, fencing and security control, exterior weatherproofing and technology upgrades.

Raymond Stoddard is the Project Manager for this project.

This item supports the Superintendent Goals related to Achievement and Customer Service. Renovation of the school to the new grade configuration will support achievement and by providing an optimal learning environment for our students as well as community collaboration and usage.
