## PURPOSE:

This action will give the Director of Planning Services and Student Assignment authority to execute a Lease Agreement with Amazing Grace Tabernacle for 5,900 square feet of space at 2102 and 2120 E Broadway Boulevard, Tucson, AZ.

## **DESCRIPTION AND JUSTIFICATION:**

Amazing Grace Tabernacle, a private religious organization is seeking a lease agreement with TUSD to use the facilities located at 2102 and 2120 E Broadway Boulevard. The approved leaseholder, the Arabian Oasis, recently terminated their lease.

Amazing Grace Tabernacle has been using the facility for religious services and community outreach since the church, which originally partnered with the Arabian Oasis, vacated the premises.

This lease would be on the same terms as the current lease and would run for five years. Amazing Grace Tabernacle will accept the premises "as-is" and will pay \$ 17,700 per year in the first year increasing to \$29,500 in the third year. Tenant will pay all utilities and other expenses. The tenant will pay for the cost of repairing the HVAC unit at 2102 E. Broadway (\$5,700.00) and maintenance for the unit at 2120 E Broadway (\$648.63) prior to occupancy. Tenant will pay the cost of all routine maintenance and repair after occupancy. Tenant shall be given credit for Capital Improvements as defined in the lease agreement.
