#### **PURPOSE:**

Tucson Unified School District Governing Board agrees to enter into a partnership agreement with the United States Environmental Protection Agency (EPA) for Green Power.

# **DESCRIPTION AND JUSTIFICATION:**

The United States Environmental Protection Agency (EPA) for Green Power Partnership encourages the voluntary use of green power to reduce the risk of climate change. Partners benefit from the use of green power, while supporting the development of new, renewable energy in the United States.

## TUSD commits to:

- \*Use green power that meets or exceeds partnership requirements
- \*Report on green power use annually
- \*Use the Green Power mark that meets the Partner mark use guidelines.

#### EPA commits to:

- \*Provide public recognition
- \*Provide procurement and communication assistance, as requested by Partnership
- \*Provide a brief description of the Partner's green power commitment on the Green Power Partnership Website.

#### General Terms:

- \*Either party can terminate agreement at any time
- \*Partner agrees that the activities it undertakes connected with the voluntary agreement are not intended to provide services to the federal government and that the Partner will not see compensation from the federal agency
- \*Partner agrees that it will not claim or imply participation in Partnership constitutes EPA approval or endorsement on anything other than its participation in the program
- \*EPA may post information about Partner's green power use publicly
- \*EPA may periodically revise program benchmark levels or other eligibility requirements

- \*Green Power Leadership Awards (These awards recognize the leaders that significantly advance the development of green power sources.
