PURPOSE:

To ask Board approval for the supplemental materials Making Connections: Engaging Students in Language, Literacy, and Global Issues. Safford K-8 would like to use these materials since they will be an authorized International Bacclaureate (IB) World School for the 2012-2013 school year. This curriculum will support implementation of the middle year's programme because it consists of a variety of challenging texts that are highly engaging and will help kids explore current global issues.

DESCRIPTION AND JUSTIFICATION:

This curriculum is suitable for grades 6-8 and also for English language learners. Since Safford K-8 will be an IB world school, teachers have been writing units according to the International Bacclaureate/Middle Years Program (IB/MYP) requirements and specifications. It is expected that teachers in the middle years programme use curriculum that helps students explore global issues. The texts in the book are research based. Students would not only develop their literacy skills, they would have opportunities for critical thinking.

At Safford K-8, the Language Acquisition teachers in grades 6-8 would be sharing this curriculum to support their IB/MYP units. This includes the ELD teacher. One of the literacy goals at the school is to increase student's reading comprehension skills and writing skills by exposing them to a variety of texts at the right ability level. The content of the book aligns perfectly with the requirements if the IB/MYP programme.

The MYP Coordinator, Ilse Billings and/or Language Acquisition teacher, Cynthia Cruz will be available to answer any questions the Board may have.
