PURPOSE:		
To approve membership with Valley Schools Employee Benefit Trust (VSEBT). Membership would allow the District to evaluate the menu benefit options offered through the VSEBT.		
DESCRIPTION AND JUSTIFICATION:		
Valley Schools Employee Benefit Trust (VSEBT) serves Arizona School Districts by offering a menu of benefit options through a Trust established by an Intergovernmental Agreement. VSEBT is part of a family of public entity pools that was created over 20 years ago for the primary purpose of saving money for it's members through collective acquisition of insurance products and services. A public entity pool is not an insurance carrier or vendor, it is a non-profit, separate legal entity formed pursuant to ARS 11-952.01 by an Intergovernmental Agreement.		
Becoming a member of VSEBT allows the District to more readily evaluate the insurance products offered by VSEBT, but does not obligate the District to use VSEBT benefit options.		
Valley Schools Employee Benefit Trust (VSEBT) membership supports the Superintendent's goal on Customer Service. It also supports fiscal responsibility by offering possible savings options for District offered employee benefit options.
