

**AMENDMENT 1**

This Amendment to the Intergovernmental Agreement effective August 1, 2013 (“Agreement”), to allow quality clinical practicum educational experiences for selected students, between Northern Arizona University, School of Health Professions and School of Nursing (“University”) and Tucson Unified School District (“TUSD”), has been prepared to revise certain provisions and the term of the Agreement.

- 1. The first paragraph of the preamble is hereby deleted in its entirety and replaced with the following:

This Intergovernmental Agreement, hereinafter called the “Agreement” is entered into pursuant to Arizona Revised Statutes hereinafter called “A.R.S.” §11-952, by and between Arizona Board of Regents for and on behalf of Northern Arizona University, College of Health and Human Services, hereinafter called “the University”, and Tucson Unified School District hereinafter called “TUSD.”

- 2. Section 7. Miscellaneous Terms:, subsection b) is hereby deleted in its entirety and replaced with the following:

b) Each party to this Agreement warrants compliance with A.R.S. §41-4401, A.R.S. §23-214, the Federal Immigration and Nationality Act (FINA), and all other federal immigration laws and regulations.

- 3. Section 8. Notice: is hereby deleted in its entirety and replaced with the following:
