PURPOSE:

To provide a timeline and gather feedback from the Tucson Unified Governing Board on the 2017-2018 301 Performance Based Plan.

DESCRIPTION AND JUSTIFICATION:

The TEA/TUSD Joint 301 Committee has meet to develop the 2017-2018 301 Pay for Performance Plan. State statute requires the pay for performance portion of the 301 plan be linked to teacher evaluations beginning SY 2014-2015.

The Joint Committee reviewed comments and suggestions that were gathered through the 2016-2017 amendment processes. Language from the amendment processes and clarifying language is incorporated into the 2017-2018 301 Plan.

The Committee incorporated the language from the 2016-2017 Second Amendment into the 2017-2018 301 Plan. This addresses any carry-forward funds above 5% of the 2017-2018 301 Revenues received from the State The language ensures the 2017-2018 funds are expended through the implementation of the 2017-2018 301 Plan Year. The Joint Committee also clarified language pertaining to the 90 student contact day requirement. The language allows persons who take a Leave of Absence the opportunity to complete the 90 student contact days if they have completed the required number of PLC hours prior to the verification date.

The formula to determine the 1.0 FTE 301 Allocation is included in the 2017-2018 301 Plan. Eligibility criteria was furthered clarified reflecting salary schedules TDR-A and TDR-B as well as the Memorandum of Agreement (MOA) between TUSD and TEA addressing persons moved to TDR-B, which will be "grandfathered" for the 2017-2018 301 Plan Year and future plans in accordance with the language of the MOA.
