PURPOSE:

To request Governing Board approval to renew the current Intergovernmental Agreement between Tucson Unified School District and University of Arizona for the Think Tank ACT/SAT Study Sessions.

To provide opportunities to all 10 comprehensive high schools: Catalina, Palo Verde, Santa Rita, Sahuarro, Sabino, Rincon, University, Cholla, Pueblo, and Tucson High.

DESCRIPTION AND JUSTIFICATION:

The IGA for the UA Think Tank ACT/SAT Study Sessions assist students from low income homes to participate in University of Arizona tutoring sessions in preparation for the ACT/SAT test.

For the 2017-2018 school year, the cost of the UA ACT prep course will continue at \$300, however the University of Arizona is requesting students contribute \$200. With an additional \$5,000 coming from the ALE budget, the ALE department will designate additional funds to cover the increased cost of the program for each student selected to participate.

ACT prep courses will be capped at 25 students.

Mr. Daniel Erickson, Director ALE will be available to address questions.
