TITLE: Lunch Price Increases for Paying Lunch Program Participants for the SY2014-2015 as Required by Public Law 111-296 Section 205 "Equity in School Lunch Pricing" for the National School Lunch Program

PURPOSE:

The full-pay lunch price set by school food authorities must comply with the pricing requirements established in the "Healthy, Hunger-Free Kids Act of 2010" (Public Law 111-296) Section 205. The price increase of 10 cents per lunch meal meets compliance requirements for School Year 2014-2015

DESCRIPTION AND JUSTIFICATION:

Section 205 of Public Law 111-296 requires school food authorities to establish full-pay lunch prices at a level that does not increase the Federal subsidy of full-pay lunches through using the free and reduced-meal reimbursement to cover costs of providing the full-pay meal or in lieu of or combination with the selling price provide funding from other non-Federal sources. Using the required calculation for average paid lunch price, Tucson Unified School District's average paid lunch price is below the level of \$2.65 in School Year 2013-14. For School Year 2014-2015 the increase of 10 cents is applied to close the gap.

Full Pay Lunch Meal Prices for SY2014-2015

Elementary	2.10 (Pre-K through 5th grade)
Middle	2.60 (6th grade through 8th grade)
High	2.60 (9th grade through 12th grade)
