PURPOSE:

To approve the Intergovernmental Agreement with the Arizona Board of Regents on behalf of the University of Arizona Department of Teaching, Learning and Sociocultural Studies for Donna M. Rishor's participation at the University.

---

DESCRIPTION AND JUSTIFICATION:

The District has several teachers participating in the program on a yearly basis. The University will provide funding not to exceed \$50,000.00 annually to the District for a substitute teacher to replace the District's participant while the participant teaches in the program.

The District will provide a participant from its teaching faculty who will serve as a Teacher-in-Residence and Assistant Professor of Practice in the U of A's Department of Teaching, Learning and Sociocultural Studies. Upon completion the participant shall return to her District for a minimum of one year at the end of her tenure in the Visiting Professor Program.

This Agreement is extended through June 30, 2015 and may be renewed for subsequent years upon written agreement between the parties.
