PURPOSE:

The purpose of this Memorandum of Understanding is to establish and describe the respective responsibilities of Tucson Unified School District and the Tucson Hispanic Chamber Of Commerce Foundation in implementing the Young Entrepreneurs Academy (YEA) as an after-school opportunity for students at TUSD High Schools.

---

DESCRIPTION AND JUSTIFICATION:

The YEA program is an afterschool program sponsored by the U.S. Chamber of Commerce Foundation and Sam's Club to develop and support student entrepreneurs. This program, conducted after school hours not on TUSD campuses, will be held at other locations as determined by the Tucson Hispanic Chamber of Commerce Foundation.

The purpose of the expenditure is to provide scholarships up to \$900 per participant to underwrite the tuition for up to 15 student participants (\$13,500). Each student participant accepted into the program will pay no less than \$95 to the THCOCF, the TUSD funding will offset the additional cost of the program
