#### **PURPOSE:**

The purpose of this item is to request Governing Board approval of the revised Tucson Unified School District's Student Transportation in School Buses Policy.

#### **STATEMENT OF POLICY:**

Tucson Unified School District buses are for the Transportation of District resident students on established routes.

#### **KEY POINTS ABOUT THE POLICY:**

Policy EEA revisions clarify who qualifies for transportation; corrects school level descriptions to match current school levels (K8 added; removed junior high); removed all exceptions as these were either out-of-date or already addressed in Paragraph 3.

District resident students are eligible for transportation if they live beyond the walking distance of their attendance zone school.

Students attending a school other than their attendance zone school must provide their own transportation unless they qualify for one of the other Transportation programs.

Students receiving Exceptional Education services will be provided transportation in connection with the requirements of their Individualized Education Plan.
