#### PURPOSE:

To request Governing Board approval to purchase Supplemental Curriculum Materials in Spanish for Dual Language Elementary Schools in Excess of \$120,000. This is in addition to Scholastics materials board approved on March 10, 2015.

#### **DESCRIPTION AND JUSTIFICATION:**

The value of leveled libraries allows for delivery of challenging and engaging instruction this is guided by a culturally responsive curriculum and offers an array of multiple perspectives. Leveled libraries can expand literacy experiences and increase achievement, by closing the gap between identified student populations. The state of our current elementary leveled libraries in Tucson Unified School District is a lack of informational and non-fiction literature, and not representative of Tucson Unified School District's diverse population. The sited that have leveled libraries are lacing both the selection of high quality and high interest texts and the level of complexity required by Arizona's English Language Arts Common Core State Standards.
