PURPOSE:

Approval to Award Invitation For Bids (IFB) 16-09-20 - Locking Hardware and Supplies

DESCRIPTION AND JUSTIFICATION:

It is the intention of the Tucson Unified School District to procure new locking hardware and supplies for District departments and school sites.

This is a multi-term contract to multiple vendors beginning July 1, 2015 with annual renewal options through June 30, 2020. Award recommendation is based on abstract results per AZ Administrative Code R7-2-1031, IFB Evaluation and Award.

An Executive Summary and the department's award recommendation are provided.

The notice of Invitation For Bids was sent to Seventy-five (75) vendors using the department's official competitive sealed solicitation website AZ Purchasing. Five (5) vendors responded with bids along with sixteen (16) No-Bids.

Estimated Annual Expenditures are \$65,000 a year (X 5 = \$325,000 over the life of the contract).

A Operations Department Representative will be present to answer questions regarding the need for Locking Hardware and Supplies.

Kevin Startt, Director of Purchasing, will be present to answer questions regarding the procurement process.
