TUSD Comprehensive Magnet Plan – 2014



In 2014, a five pillar model was adopted as a framework for the Comprehensive Magnet Plan. These pillars were based on the National Magnet School Standards of Excellence.

TUSD Revised Comprehensive Magnet Plan – 2015



In 2015, the **Comprehensive Magnet** Plan was revised to meet the requirements of Court Order 1753: "All magnet schools and programs must have attained or be close to attaining integrated status and attain the five goals related to academic performance by the end of the 2016-17 SY."

Diversity Goal


Integration exists, pursuant to the definition in the USP II.E.2, based on the number of accepted magnet applications for entry grades K, 6, 9 and which is maintained at the subsequent grade levels.



No racial or ethnic group varies from the district average for that grade level by more than +/-15%

No single racial or ethnic group exceeds 70%

Student Achievement Goals



Monitoring and Reporting



The Special Master will submit two reports annually which will document:

- 1. Integration Progress
 - 40th day attendance data (2015-16 and 2016-17)
- 2. Student Achievement Results
 - State testing data (2014-15 and 2015-16)

Monitoring and Reporting



If at any point during his review the Special Master determines that it is highly unlikely that a school/program can meet the 2 goals, he may recommend that magnet status be withdrawn. Parties may appeal the decision.

Magnet School Status

A committee comprised of District representatives, a plaintiff representative, and the Special Master analyzed enrollment and student achievement data.

Magnet School Plans – All Schools

Court Order 1753 requires that the Special Master work collaboratively with sites to create plans that meet the intent of the two pillars.

As advised by the Special Master, All Magnet Schools were directed to write Magnet School Plans that:

- Utilize the Magnet Coordinator position primarily to improve student achievement, aggregate data, support classroom teachers in improving instruction, guide PLCs as needed, and still provide outreach and recruitment support
- Implement PLCs for two hour blocks of time at least once weekly
- Provide Learner Centered Professional Development (LCPD)

Magnet School Plans

In addition, "C" and "D" schools were directed to choose from a menu of other strategies designed to improve student achievement.

- Identify Teacher Leaders to facilitate PLCs.
- Reduce class size or student to adult ratio.
- Provide training on differentiated Tier 1 instruction for all students.
- Provide Tier 2 intervention within the school day.
- Provide Tier 3 interventions.
- Use a Peer Observation Model to provide lesson and instructional feedback.

Magnet School Plans – Budgeting for Success



To promote successful implementation of Magnet School Plans, budgets for the 2015-16 school year were designed around each site's Plan.
