Pursuant to The Fisher Fee Agreement (ECF 1717) adopted by the Court in its December 1, 2014 Order (ECF 1722), and later amended by the Court in its December 5, 2014 Order (ECF 1725), Tucson Unified School District No. One ("TUSD") and the Fisher Plaintiffs (collectively "the Parties") hereby request the Court's approval of the Parties' resolution of Fisher Plaintiffs' Fee Requests for the periods of April 3, 2013 through December 31, 2014 and January 2, 2014 through December 31, 2014 for the total amount of \$393,750.00.

On February 3, 2015, TUSD received the Fisher request for the period of April 3, 2013 through December 31, 2013 in the amount of \$246,260.00 in fees and no costs. On April 30, 2015, TUSD received the Fisher request for the period of January 2, 2014 through December 31, 2014 in the amount of \$283,640.00 and no costs.

Pursuant to the Parties' stipulated agreement, TUSD notified Fisher Counsel promptly of those matters with which it disagreed, and the Parties worked together to address the issues raised by TUSD. The Parties have agreed to resolve both requests jointly for a total settlement of \$393,750.00. The parties further agree TUSD will submit payment directly to counsel for Fishers within 30 days after the Court enters its order approving this stipulated motion. Should the Court disapprove this stipulated motion, the parties shall present briefing to Magistrate Judge McDonald for review and decision in accordance with the Fisher Fee Agreement.
