## PURPOSE:

Authorize funding for the use of Public Transportation from the City of Tucson for the Purchase of bus passes for middle, high school, and exceptional education students for Fiscal Year 2014-2015.

## **DESCRIPTION AND JUSTIFICATION:**

The Tucson Unified School District provides bus passes to middle and high school students living outside the 2.5 mile walk distance. The eligible ridership for the 2014-2015 school year is approximately 3500 students per day. Currently, monthly passes are \$42.00 each and daily passes, to support intervention programs, are \$3.50 per day.

This procurement is made sole source through Sun Tran, the only public transportation system within the City of Tucson.

It is requested that the Board approve \$820,000 for the purchase of Sun Tran bus passes for Fiscal Year 2014 - 2015.

This item supports the goals and requirements of the Unitary Status Plan. The Deseg funding included in this item is subject to court approval and may not be available.

This item supports the Superintendent Goals related to Achievement, Student Enrollment, Customer Services, and Transportation. The use of monthly bus passes provides increased transportation options for students and additional flexibility in the student's ability to become involved in after school activities outside of the academic day. Bus passes improve transportation customer service. Drop-out Prevention is supported by the use of daily bus passes for at risk students as an incentive to encourage student attendance at school which improves access and the ability to successfully complete their academic coursework. Transportation is supported by increasing customer satisfaction and efficiency with transportation options.
