Additional Discussion and Decisions:

2. SCPC Elections for 2013/2014 School Year:

Decisions:

- 1. A proposal was made to appoint a "back up" for Board Liaison. This would ensure that SCPC provided information at each board meeting in the event the current Board Liaison could not be in attendance.
- 2. The group agreed to coordinate with the Board Liaison and make sure that a member of the executive committee or representative as determined is in attendance at the board meetings where the Board Liaison cannot be in attendance.

3. SCPC Priorities for 2013/2014 School Year:

Notes: The group revisited the discussion about the Unitary Status Plan and the impact on the district and community. This topic needs to be addressed in the upcoming school year and additional presentations should be considered. The group also discussed the need to focus on topics that are pertinent to the community, parents, school district, and school board. The coordination between the board and the SCPC is crucial to this process. Having board members in attendance has had a positive impact on the group.

Group discussions also focused on how to promote SCPC, its relationship with the board and district, how to communicate the purpose of SCPC to the greater community, and clear expectations of all stakeholders. The group discussed ways to involve the community, parents, and staff in the activities of SCPC. A coordinated effort must occur within the SCPC membership to increase diversity and attendance within the group.

Continued focus on the financial concerns of the district and transitions are a priority for the upcoming school year. Presentations regarding these topics are of great importance to the group.

Decisions:

- Promotion to TUSD administration and principals about the importance of SCPC and how it is different from Site Council is crucial. A membership committee will be created to address this issue.
- 2. Requests will be made for additional presentations about the Unitary Status Plan, School Master Plan, and Budgetary information.
- 3. Requests will be made for presentations regarding transitions to include moving to a new school and between grade transitions.
- 4. A request will be made for the new Superintendent to meet with SCPC in the beginning of the school year.
- 5. Planning meetings will provide greater focus and structure for the content presented at the General meetings.
- 6. The group would like to "showcase" schools within the district at General meetings in order to promote what TUSD "does right" versus always hearing about what is wrong.
