### PURPOSE:

To Purchase/Renew Liability, Property, Pre-Paid Legal, Automotive, Workers' Compensation and other services from the Arizona School Risk Retention Trust (The Trust)/The Arizona School Alliance for Workers' Compensation Inc. (The Alliance).

### **DESCRIPTION AND JUSTIFICATION:**

The Trust/The Alliance continues to provide insurance on behalf of the District. The insurance coverage will include general liability, automotive liability, administrative practice liability, excess liability, all risk property, commercial crime, storage tank liability, pre-paid legal services and workers compensation. The Trust/The Alliance is a state authorized insurance pool.

The scope of services and associated costs are detailed in the attached Proposal Acceptance Forms (PAF) from The Trust and The Alliance. While all district deductibles will remain the same, the district would benefit from increasing the number of vehicles with auto physical damage coverage. This action will increase auto physical damage to cover all vans and busses valued above the deductible.
