Election Department's costs are subject to change dependent on: (a) the number of TUSD schools used to operate polling places versus non-TUSD schools, which require a rental fee to the polling location; (b) the number of consolidated voting precincts, which also affect poll-related costs; (c) the actual number of early ballots returned and verified; this scenario assumes 95% of the 25% early ballots returned are valid.
- 3. Superintendent's costs are subject to change dependent on: (a) the actual number of words translated from English to Spanish; (b) the actual number of voter information pamphlets printed for mailing of one per household with at least one registered voter in TUSD; (c) the actual number of voter information pamphlets mailed and; (d) the number of pages contained in each voter information pamphlet.
