| PURPOSE: Lunch Price Increases for Paying Lunch Program Participants for the SY 2017-2018 as Required by Public Law 111-296 Section 205 "Equity in School Lunch Pricing" for the National School Lunch Program | | | | |
| DESCRIPTION AND JUSTIFICATION: Section 205 of Public Law 111-296 requires school food authorities to establish full-pay lunch prices at a level that does not increase the Federal subsidy of full-pay lunches through using the free and reduced-meal reimbursement to cover costs of providing the full-pay meal or in lieu of or combination with the selling price provide funding from other non-Federal sources. Using the required calculation for average paid lunch price, Tucson Unified School District's average paid lunch price is below the level of \$2.86 in School Year 2016-17. For School Year 2017-2018 the increase of 10 cents is applied to close the gap.
