PURPOSE:

Consider and approve the attached resolution ordering and calling for an election to authorize the sale of TUSD properties. The form of the ballot for such an election shall be in substantially the form attached as Exhibit A to the resolution.

DESCRIPTION AND JUSTIFICATION:

If the Governing Board calls for this election, this would be the first step to allow the District to sell the schools closed in 2013. If the authorization to sell is approved by the voters, TUSD would not be required to sell the properties but could sell them by a separate Board vote in the future, if they determine them to be surplus.

The attached resolution outlines the procedures necessary to facilitate the election. As shown in the attached Checklist and Timeline, the deadline to call for the election is June 27, 2014 and the deadline to submit this resolution is July 7, 2014.

The estimated cost of this election is shown in the attached Projected Costs tables. An election in November is expected to cost about \$235,000; a special election in May would cost about \$775,000.

How this relates to Superintendent Goals: This item supports the goal to increase outside funding by providing revenues to the District.
