PURPOSE:

Approval of the expenditures for virtual classroom services using previously Board approved online curriculum material vendor Edgenuity.

DESCRIPTION AND JUSTIFICATION:

Adoption process 14-13 was executed in 2013 and Board Approved in October of 2013 for virtual instructional materials for all content areas K-12. The adoption process selected several online materials vendors, including Edgenuity. The online curriculum provides content for online students, credit recovery, and credit acceleration. See attached Executive Summary from October 2013 for information on Adoption 14-13 and the associated procurement process. Continued use of this material is requested by the Curriculum and Instruction.

Expenditures for Edgenuity for fiscal year 2018-19 are estimated at \$325,000, which includes unlimited district-wide access and the specified professional development services. A quotation is attached that details the proposed services.
