PURPOSE:

Approval of expenditures for supplemental online curriculum materials for previously Board Approved online curriculum materials Pearson Successmaker using a Strategic Alliance of Volume Expenditures (SAVE) cooperative contract.

DESCRIPTION AND JUSTIFICATION:

Pearson Successmaker intervention supplemental curriculum material was previously approved by the Board for use in the District in January of 2013. Concurrent licenses for District wide use were purchased using a SAVE cooperative purchasing contract. The online curriculum provides content for intervention for students. Continued use of this material is requested by Curriculum and Instruction.

Expenditures for Pearson Successmaker for fiscal year 2018-19 are estimated at \$409,000 for license renewal, updates, maintenance, support and professional development as specified. A quotation is attached that details the proposed services.

The Purchasing Department has performed the due diligence on the requested cooperative contract and has determined that the competitive process that was performed by the SAVE Agency (Glendale Elementary School District) is in compliance with AZ Admin. Code R7-2-1041 - Competitive Sealed Proposals and that the negotiated fees that Pearson is offering under this cooperative contract are fair and reasonable. The use of the cooperative contract by the District is authorized by AZ Admin. Code R7-2-1191 - Cooperative Purchasing Authorized and by Governing Board Policy DJ.

A representative from Curriculum and Instruction will be present to answer questions regarding the use of this online material.

Kevin Startt, Director of Purchasing, will be present to answer questions regarding the procurement process.
