

### Initiatives reflect Beliefs

- What we believe is what we practice!
- We believe:
  - All Kids are Capable of Success No Exceptions!
  - We facilitate change through the use of evidence-based practices and programs
  - Pre-Adjudicated use of detention should be restricted to those youth who are a high risk to re-offend prior to completing the court process – or are a high risk of not attending their next court hearing
  - Low Risk Youth should be Diverted from the court process
  - Interventions for youth on probation should be targeted toward their highest criminogenic needs – based on a validated risk/needs assessment

## What Works?





Concentrate efforts toward HIGH and Moderate RISK Youth

Target Interventions toward highest Criminogenic NEEDS

• Be **RESPONSIVE** to strengths and barriers, such as culture, language, learning style, stages of change, developmental stages, trauma, economic situation and natural supports

## What are Criminogenic Needs?

#### Top (BIG) Four

- Antisocial Behavior (Juvenile Justice History)
- Antisocial Personality (temperament, pro-social skills)
- Antisocial Cognition (thoughts and beliefs)
- Antisocial Associates

#### **Next Four**

- Family
- Substance Abuse
- School
- Leisure

## What Doesn't Work?

- Overuse of Detention
- Supervision Centric Probation / Over Supervision
- Targeting Substance Abuse alone when it is a result of a Big Four
- Programs based on fear

# What Can Be Improved?

# Results -> Lower Crime Rates & Safer Community

	2004	<u>2015</u>	
Population*	122,258	123,105	+.7%
Referrals	15,953	7,846	(-51%)
Felonies	3,472	1,993	(-43%)
%Ref = Felonies	21.7%	25.4%	+3.7%
Transfer to Adult	90	70	(-22%)



# Targets for Improvement

	<u>2004</u>	<u>2012</u>	
Successful Diversion	76%	83%	+7%
Successful Probation	69%	76%	+7%
Successful Intensive Probation	63%	71%	+8%

## Where to Next? $\rightarrow$ What Can You Do?

- Help Youth Avoid the System
  - Organizations (SCHOOLS) can provide PROVEN Prevention Programs and Services
  - Neighborhoods (SCHOOLS) can support POSITIVE activities for youth
  - Individuals (TEACHERS, STAFF) can be an ACE (positive adult) in a Kid's Life
- Help JJ Involved Youth Avoid Recidivism
  - Education is Paramount
  - Support Kids and Families of Youth on Probation
    - Consider Mediation if YOU or Community is a victim of juvenile crime
    - Give OPPORTUNITIES for Kids to SUCCEED
    - Remember that the adolescent brain is still developing Kids are NOT small Adults!
    - Be an ACE in a Kid's Life
