PURPOSE:

Review, approve and adopt revised employee salary schedules in the TEA Consensus Agreement which, upon receipt of the Prop 123 funding by Tucson Unified School District, will increase the base salary schedules in Articles 29-13 and 29-14 by \$700 and approve the attached revised 16-17 Consensus Agreement which incorporates these revised salary schedules.

DESCRIPTION AND JUSTIFICATION:

The 16-17 employee agreements, approved by the Governing Board on May 10, 2016, permit the Governing Board to increase 16-17 employee salaries if the District receives additional revenues from the State which are available for salaries. The Arizona Education Finance Amendment, Proposition 123, approved by voters on May 17, 2016, authorizes the State to appropriate additional funds to the District which are available to pay salaries. The State has begun to distribute Prop 123 monies to school districts. Through the attached Memorandum of Agreement, TEA has approved these revisions for the employees subject to the Consensus Agreement.
