PURPOSE:			
Review, approve and adopt revised classified employee salary schedules to increase base salaries for classified employees by 1% upon receipt of the Prop 123 funding, as set forth in the attached separate Memorandums of Agreement with AFSCME, CWA and TEA, and approve the attached revised 16-17 employee agreements for AFSCME, CWA, TEA White Collar/Food Service, and Non-Bargaining Group employee groups which incorporate these new salary schedules.			
DESCRIPTION AND JUSTIFICATION:			
The 16-17 employee agreements, approved by the Governing Board on May 10, 2016, permit the Governing Board to increase 16-17 employee salaries if the District receives additional revenues from the State which are available for salaries. The Arizona Education Finance Amendment, Proposition 123, approved by voters on May 17, 2016, authorizes the State to appropriate additional funds to the District which are available for salaries.			
The State has begun to distribute Prop 123 monies to school districts. Through the attached Memorandum of Agreements, AFSCME, CWA and TEA have each approved an increase of 1% to the base salary schedules for their respective employee agreements.
