PURPOSE:

Review, approve and adopt a Memorandum of Agreement with ELI regarding the use of Prop 123 funding for employees governed by the 16-17 ELI Meet and Confer Agreements for Administrators, Psychologists and Research Project Managers which increases the base salary on all ELI salary schedules by 1%; increases the base salary for psychologists to align with the market to make these positions easier to fill; and permits adjustment of psychologists step placements on the revised salary schedule to align with their years of experience working at Tucson Unified School District.

DESCRIPTION AND JUSTIFICATION:

The 16-17 employee agreements, approved by the Governing Board on May 10, 2016, permit the Governing Board to increase 16-17 employee salaries if the District receives additional revenues from the State which are available for salaries. The Arizona Education Finance Amendment, Proposition 123, approved by voters on May 17, 2016, authorizes the State to appropriate additional funds to the District which are available to pay salaries. The State has begun to distribute Prop 123 monies to school districts. Through the attached Memorandum of Agreement, ELI has approved these revisions for the employees subject to the ELI Agreement.
