| PURPOSE: | | |
| This action will amend the lease with the Pascua Yaqui Tribe at Richey School, 2209 North 15th Avenue, to revise the areas needed by TUSD for the charter school, to set a date for occupancy by the Tribe and to extend the lease accordingly. | | |
| DESCRIPTION AND JUSTIFICATION: | | |
| The subject lease was drafted to create a partnership between the Pascua Yaqui Tribe (Tribe) and TUSD for coordinated uses of the Richey site. It was approved on February 14, 2012 and executed on March 1, 2012. Subsequently, the Tribe and TUSD met to transition the property to the Tribe, but this transition was not completed and the Tribe did not accept occupancy. | | |
| This amendment to the lease changes the location of space to support TUSD's charter school, sets a date to allow occupancy by the Tribe and extends the terms of the lease by one year as the Tribe has not yet occupied the building. | | |

| HOW THIS RELATES TO SUPERINTENDENT'S GOAL(S): This lease has the potential to support Achievement by providing a site, at a reduced expense, for a charter school to support early childhood education.
