PURPOSE:

To propose comprehensive revisions to GCAB, concerning mainly the appointment of administrators, to:

- \*establish guidelines for the interview process, including the role of site councils and the principal in the process for site administrators, the composition of interview committees including the appointment of subject matter experts, facilitating the use of interview questions that focus on subject matter expertise, and encouraging the use of interview questions adapted to the circumstances of specific candidates;

- \*clarify which appointments require stand-alone approval by the board and what information is provided to or accessible by the board during the process;

- \*require approvals for ESI-employed administrators similar to the rules for other administrators;

- \*clarify the rules for emergency appointments;

- \*make other minor clarifying or simplifying changes.

External and internal counsel have aided in the preparation of these proposed changes.
