### PURPOSE:

Policy JLIF enacts at the District level a uniform policy concerning statutory notifications required at the schools concerning adult sex offenders, juvenile sex offenders, and dangerous juvenile offenders.

---

### STATEMENT OF POLICY:

TUSD is required to enact certain portions of ARS 13-3825 and 8-350 at the school and district level. The proposed Policy was first reviewed and approved by a committee led by Jeff Coleman and included the input of Rob Ross, Nicole Lowery (Risk Management), Tammy Hille (Guidance & Counseling). Maura Clark-Ingle (Exceptional Education) was invited to provide input.

The Governing Board approved this proposed Policy language at the 4/10/18 Board meeting and sought comments from the public. One comment/question has been received (see attached). After the Board finalizes and adopts Policy JLIF, Jeff Coleman's Committee is prepared to make recommendations for the effective rollout of this new policy (training, notice, procedures, etc).

### KEY POINTS ABOUT THE POLICY:

Directs the Superintendent to establish procedures to:

1) disseminate the information received from local law enforcement to staff, parents, guardians, custodians (and, if deemed appropriate, students) when the District has been notified that a registered offender has moved into the community (ARS 8-350).

2) measures to provide to teachers, parents, guardians or custodians, upon request, information received by the District under ARS 8-340 regarding juveniles in attendance who have been adjudicated delinquent of "dangerous offences" or sex offenses.
