EXCEPT AS MODIFIED HEREIN, all terms, covenants and conditions contained in said Shared Use Lease Agreement, shall remain in full force and effect, This Addendum, along with the original Lease Agreement constitute the entire agreement between the parties, and integrate and supersede all understanding of agreements, written or verbal, with respect to the same except as expressly written in the First Addendum, or in the Shared Use Lease Agreement.
