PURPOSE:

To request Governing Board approval to purchase Supplemental Curriculum Materials in Spanish for GATE Literacy Kits. These kits will be available for check out by GATE Itinerant, Self-Contained and Cluster gifted endorsed teachers for the purpose of supporting English Language Learners and all students in GATE Dual Language programs.

DESCRIPTION AND JUSTIFICATION:

As specified by the Unitary Status Plan, the GATE Department, in collaboration with the Language Acquisition Department, must use best practices strategies to support Latino students receiving GATE services. As a result, we have created Spanish Literacy Kits that will be used as a part of challenging and engaging instruction and a culturally responsive curriculum that offers an array of multiple perspectives. The GATE literacy kits can expand literacy experiences and increase student achievement by closing the achievement gap between identified student populations and their non-second language peers. Our Latino GATE students should have access to materials in Spanish to help them achieve the level of complexity required by Arizona's English Language Arts Common Core State Standards and challenging instruction they will encounter in the GATE program. The GATE Spanish literacy kits will consist of fiction and nonfiction text, with emphasis on nonfictions selections. The kits will support the building of knowledge through content rich nonfiction. The informational reading selections will include content-rich nonfiction in history, social studies and the sciences and will support students in systematically developing knowledge about the world. In addition, the texts for each grade level will include a variety of reading levels to support as well as to challenge all students.
