### PURPOSE:

TUSD and THCOCF desire to continue existing relationship to offer YEA as an after-school option during the 2017-2018 school year in a similar format as that used last year and pursuant to the terms of agreement.

### DESCRIPTION AND JUSTIFICATION:

YEA operated as an after-school program exclusive to TUSD high school students. Students applied for and were selected to participate in the program through THCOCF. The program took place after school hours at non-TUSD sites supplied by THCOCF, and a Program Coordinator, employed by THCOCF, ran and provided instruction for the course. TUSD underwrote \$900.00 of the tuition for each of the twenty-four (24) TUSD students who attended the 2016-2017 programs by paying that amount directly to THCOCF on behalf of the student participants. The student participants paid the balance of their tuition directly to THCOCF as well.
