PURPOSE:

To approve award of IFB 16-30-20, Health Supply Items, as needed, for District sites and schools.

DESCRIPTION AND JUSTIFICATION:

This is a multi-term contract with awards recommended to multiple vendors beginning upon award with annual renewal options through June 30, 2020.

Determination has been made to award IFB 16-30-20 to multiple vendors to meet the extensive and varied needs of the District. Based on the demographics of the District, the variety of health supplies needed for all District schools, it has been determined to be in the District's best interest to award this contract in this manner. As one of the largest school districts in Arizona, it is determined that awarding to multiple vendors would provide the needed quantity, diversity of products, quality, service and/or delivery needed to the district. Historically the district has had the need to award this type of contract to multiple vendors which has proven advantageous to meet the significant volume and diversity within the District.

Award recommendation is based on abstract results per AZ Administrative Code R7-2-1031, Bid Evaluation and Award.

An Executive Summary is provided for review. The notice of Invitation for Bids was sent to 211 vendors using the Purchasing Department's official competitive sealed solicitation website AZ Purchasing. (53) Vendors downloaded the bid, (9) vendors responded with bids and there were 38 No-Bids. Estimated Annual Expenditures are \$155,000 a year (X 5 = \$775,000 over the life of the contract). Expenditures come from various school and department budgets.
