SCIENCE RESOURCE CENTER KIT RENTAL AGREEMENT BETWEEN TUCSON UNIFIED SCHOOL DISTRICT AND

St. Cyril of Alexandria School

Tucson Unified School District ("TUSD") of Tucson, Arizona agrees to provide services to **St. Cyril of Alexandria School** during the period September 1, 2018 to June 30, 2021 subject to annual review for performance by both parties. For this purpose, TUSD and St. Cyril of Alexandria School mutually agree on the following:

- 1. <u>Location:</u> St. Cyril of Alexandria School (hereinafter, "St. Cyril" or "partner"), is located at 4725 E. Pima Street, Tucson, AZ 85712.
- 2. Purpose of the Rental Agreement between TUSD and St. Cyril:
 - a) To provide science kits/units correlated to the State Science Standards to St. Cyril for the purpose of enhancing science education.
 - b) To provide professional development as requested by St. Cyril to support the implementation of the science kits/units as well as State Science Standards.

3. Term:

The term of this Agreement is from September 1, 2018 to June 30, 2021.

The parties have authority to enter into this Agreement pursuant to the provisions of A.R.S. § 15-1108.

4. <u>TUSD will</u>:

- a) Provide a list of K8 science kits by grade level for partner to select from (Attachment A).
- b) Provide partner with a cost sheet for each kit by grade level, replacement of non-consumable items, and extension of kit use fee (Attachment B).
- c) Provide produce and insects/live organisms for identified science kits at time of kit pick up if SRC is given request 2 weeks in advance of pick up date. Exception to live organism (i.e. Crayfish, land snails) availability is dependent on TUSD being able to secure organism from vendor.
- d) Send an invoice to St. Cyril within thirty (30) days of kit pick-up.
- 5. <u>TUSD upon request will provide professional development</u> opportunities by a trained facilitator for the following:
 - a) K-8 Foundational courses (minimum of 9 hours not to exceed 15 hours) provided by a trained facilitator after school or in the summer.
 - b) Science Education topics (e.g. Science Notebooks, 3-Dimensional Science) taught by a trained facilitator using a hybrid approach (e.g. Study Groups, On-line, Face-to-Face).
 - c) Send an invoice for professional development services within thirty (30) days of services provided.

6. St. Cyril will:

- a) Inventory science kit(s) at time of pick-up to ensure all resources are in kit.
- b) Pay TUSD for kits received within thirty (30) days of receipt of invoice.
- c) Pay TUSD for services rendered and costs incurred within thirty (30) days of receipt of invoice.
- d) Reimburse TUSD for loss of any non-consumable item(s)/kit at replacement cost.

7. <u>Joint Responsibilities</u>:

- a) TUSD and St. Cyril will communicate changes to the delivery/pick-up schedule within 2 days of agreed upon schedule.
- b) TUSD and St. Cyril will schedule an annual consultation to review options available through Agreement.

8. <u>Insurance and Liability</u>:

TUSD and St. Cyril must maintain minimum liability and workmen's compensation insurance as required by state law and the Federal Acquisitions Regulations. Neither party to this Agreement is the agent of the other and neither is liable for the wrongful acts or negligence of the other. Each party agrees to indemnify and hold the other party harmless for any claims arising from the conduct of the others.

9. <u>Modification of Agreement:</u>

A mutual act of the parties to this Agreement is necessary to make any modification to this Agreement. No amendment or modification of this Agreement shall be valid or binding unless written and signed by both the TUSD and St. Cyril.

10. <u>Disputes:</u>

Any controversy or claim arising out of or relating to this Agreement, its execution or breach, and any damages allegedly suffered there from, first shall be submitted to negotiation between the Parties. To facilitate the amicable resolution of any controversy or claim, the aggrieved Party shall document the dispute or misunderstanding by promptly notifying the other Party in writing of the relevant facts, unresolved issues, and the clarification or remedy sought. The other Party shall submit a written position on the matter(s) in dispute within thirty (30) calendar days after being notified of the controversy or claim.

11. <u>Termination:</u>

Either party may terminate this agreement upon ninety (90) days advance notice to the other party. Upon termination:

- a. St. Cyril will pay TUSD for the cost of any kits TUSD scheduled for the Agreement year.
- b. Payments and credits under this termination provision shall be in accordance with Attachment #B of this Agreement.

12. Non-Discrimination:

The parties agree to comply with the applicable State and Federal rules governing Equal Employment Opportunity and Non-Discrimination, and immigration.

13. Notices

Notices shall be in writing and deemed effective when sent, postage prepaid to:
